COVID-19 Response

In response to the increase in COVID-19 cases, Freeport-McMoRan donated more than 13,100 KN95 masks to healthcare facilities and schools in our operating communities.

Freeport-McMoRan Morenci continues to support and partner with key stakeholders on COVID-19 activities.

2020 United Way Campaign

North America employees pledged approximately **\$3.5 million** during the 2020 campaign; and more than **\$9.5 million** when including the company match.

Morenci employees pledged \$1,226,755.21, plus a company match of \$2,268,194, for a total of \$3,494,949. Morenci is proud to partner with the United Way of Greenlee County supporting organizations such as:

- Morenci Lions Toy Drive employees donated 1,450 toys
- White Mountain Apache Tribe Angel Tree employees "adopted" 44 children / youth and 38 senior citizens
