The Copper Mark was awarded to Cerro Verde in Peru, El Abra in Chile, Atlantic Copper (first in their respective countries) and Miami and El Paso Refinery. Other U.S. sites are scheduled to be assessed in 2021.

Safety

- TRIR 1.06, versus a target of 2.33
- Smelter: four “low energy” reportable incidents in 2020
- 834 Zero Days at the rod mill and 4,573 at Pinal Creek Project

Environmental

- First year achieving 99 percentile since 75ppb SO₂ standard was adopted

Operations

- Mine
 - More copper produced in 2020 than in the previous two years
- Smelter
 - All-time record in concentrate smelted and sulfuric acid produced

Environmental Update

Renewable Energy - Climate

- SRP's Saint Solar Plant
 - Located in Coolidge, Ariz.
 - 100-megawatt solar energy production
- Miami operations is lowering its scope 2 carbon emissions with a 20-year commitment to purchase power from Saint Solar
 - The smelter will receive approximately 5% of its electrical energy from Saint to align with company's stated target of 15% reduction by 2030
 - United Nations Sustainable Development Goals for clean energy and climate action
 - Copper Mark criteria target energy consumption, greenhouse gases and pollution prevention
 - Complements Freeport-McMoRan energy initiatives
