Staff provided an update on current employment and vacancy numbers at Morenci and Safford as well as ongoing and upcoming projects.

- Morenci shared information on two permit exceedances reported to ADEQ, one related to a failed Power House stack testing, and the other related to a leakage rate exceedance at the Silver Basin stockpile PLS pond. We also shared information on three agency inspections, two by ADEQ and one by the Army Corps of Engineers that resulted in no findings. Provided an update on the Producer Stockpile project, and shared Freeport's goal of 15% reduction of our carbon footprint by 2030, as part of Freeport's Climate Change Initiative.
- Shared an update on the Clifton Soil Program.

Morenci has responded to two community grievances over the last quarter. Topics of concern included:

- A resident complained to the Town of Clifton about the demolition of Morenci Water & Electric's (MWE) old electrical substation building, claiming it was an historical building
- The owner of a local restaurant opined that Freeport-McMoRan should share the cost of the repairs to the sewer line that was accidentally damaged by MWE personnel due to the location of a sewer line being incorrectly identified.
