#### Purpose

The [Community Partnership Panel](#) is hosted by Freeport-McMoRan to keep the community informed about operational activities and to foster open and ongoing dialogue to develop thoughtful solutions to address community issues.

#### Operations Update — Copper Queen Branch

- The Copper Queen Branch submitted an Aquifer Protection Permit application to ADEQ at the end of December 2017
  - The application is currently in the review stage
  - A public comment period is expected to occur during the third or fourth quarter of 2018

#### Upcoming Projects:

- Removal of inactive power lines and steel towers historically used to transmit power across the property
  - The power line removal project may cause slight traffic delays on Highway 80 near the pit
  - Another phase of the project will involve the removal of lines and towers along Hillside Avenue in Galena
- Removal of a mile-long pipeline between Mule Gulch and Highway 80

#### Reclamation:

- Reclamation of the South Bisbee Stockpile is scheduled to resume in the 3<sup>rd</sup> quarter 2018

#### Queen Mine Experience:

- Gallagher & Associates continue to work on the feasibility study for the expansion of the Queen Mine Tour

#### Residential Soil Remediation:

Over 4,200 commercial and residential properties in the Bisbee area were sampled and tested for metals that may have been associated with former mining operations as part of the 2008 Freeport-McMoRan Bisbee Soil Program. Currently, a portfolio-wide soils program assessment is being conducted to determine the interest of those few property owners who did not participate in soil testing before the program concluded.

Freeport-McMoRan is committed to working with interested property owners. At this time there is no set timeframe to conduct additional residential soil testing in Bisbee.
