#### **Operations Update**

**Projects:** 

- Thickener demolition and re-sloping completed. Drainage channels will be constructed to divert stormwater.
- Fencing along Highway 80 has been repaired. Inspection of the rest of the fence around the pit perimeter will be completed to assess structural integrity.
- Engineering study will occur on the pit highwall by Highway 80 to identify safety solutions.
- Upgrades to fire flow and potable water systems will be assessed to replace obsolete tanks and pipes.

#### **Environmental Update**

#### Soil Remediation:

- Approximately 20 properties have been restored in Douglas, with additional properties scheduled for the free, voluntary soil sampling program.
- To date, 18 properties have been restored in Bisbee, with plans to complete work in Q3 2025.

#### **City of Douglas:**

 Funding from Freeport is supporting the City of Douglas Sustaining Mobility program, which provides operational support to the Transit Division.

• Funding this program supports workforce stability, access to services, and economic stability in the community.

#### City of Bisbee:

- The City of Bisbee has rebuilt its City Hall, which was demolished in 2020 after a fire in 2017. Bisbee was able to preserve the historical footprint of the original Hall, while outfitting it with modern technology.
- Freeport supported this endeavor by funding modern audio-visual technology and accessibility features that enhance the opportunity for civic engagement, including hosting community meetings and restarting the Youth Council.

## **Grievance Management**

#### **Grievance Report**

Freeport maintains a formal Grievance Management System allowing community stakeholders to share concerns directly with company officials, which we reviewed in detail at the Q2 CPP. Learn more about this process below:



**Receipt:** Freeport receives concerns (grievances) from the community in person, via phone, email, website and/or mail. The more details shared, the better, so we can properly investigate and remedy the situation. Concerns can be submitted anonymously.

**Confirmation:** Freeport confirms receipt of inquiries within 48 hours of receipt.

**Review:** Freeport coordinates with the appropriate internal experts to review.

**Response:** Freeport provides a formal response to the individual or group by phone, email or mail. No formal response can be shared for those received anonymously.
