#### Climax Mine 2020 Priorities

- Climax is focused on delivering immediate value at site and for the company
  - Delivered additional cost reductions in 2Q and the remainder of 2020 as result of project timing, internalization of work, and other efficiency gains
  - Focused on driving a more agile mindset, engaging employees at all levels to redefine new ways of doing business work from home for as many as possible, leveraging technology, etc.
- Headcount as of end of July
  - Climax operations: Approximately 370 employees
  - Henderson operations: Approximately 390 employees
- Environmental Updates
  - Regarding recent news articles about the Eagle River Memorandum of Understanding (ERMOU) and expansion of the reservoir in the Holy Cross Wilderness, the ERMOU provides to Climax 3,000 acre-feet of storage capacity in an expanded Eagle Park Reservoir, so Climax has no interest in the proposed reservoir
