The Copper Mark was awarded to Cerro Verde in Peru, El Abra in Chile, Atlantic Copper (first in their respective countries) and Miami and El Paso refinery. Other U.S. sites are scheduled to be assessed in 2021.







2020 Highlights

Environmental, Health & Safety & Security (EHSS)

- Successfully managed COVID-19 challenges ensuring continuity of operations
- Reduced the number of Health and Safety and environmental incidents compared to 2019
- Substantially completed engineering (>90%) for relocation of NPDES treated water discharge force main into Mississippi River
- ACC Responsible Care® Management System (RCMS:2019)
 Certification achieved in September 2020

Operations

- Successfully managed changing production and sales requirements, and challenging business environment due to COVID-19 pandemic
- Optimized headcount thanks to redesign of work processes
- Cost targets for the site were met while I fulfilling all maintenance and production requirements
- Added capacity for Pure Oxide Calcined (POC) production, one of our highest demand chemicals

2021 Q1 Focus - Challenges and Opportunities

- POC Production Maximization of calciners asset efficiencies and capacities due to higher actual than expected demand
- Continue efforts to maximize ammonia recovery from our chemical plant processes
- Tight transportation market as world economic activity picks up
- Timely supply of production goods to our site
- Product shipping container availability
- Truck availability
- Planning and securing materials and services for an incident-free and productive annual turnaround
- Achieve substantial progress with acid plant converter replacement engineering and equipment procurement
- Converter replacement scheduled for 2022 capital deployment
- Begin construction of the new force main to Mississippi River in July 2021
