### Purpose

Current employment at <u>Safford operations</u> is 1,250 with 140 vacancies and approximately 375 contractors working at-site in support of various projects including: upgrades to existing processing infrastructure and construction of the Lone Star leach pad. Contractor numbers will decrease to pre-Lone Star levels in early 2020 as construction projects are completed.

One project, the February move from the Phase II leach pad to the new Lone Star leach pad, concluded 14 years of stacking on the original leach pads during which 2.08 billion pounds of copper were placed – enough to build 4 million typical homes or 38 million cars.

Central Analytical Services Center and Sanchez Technology Center, process support sites in Graham County, have a combined employment total of approximately 240.

<u>Morenci operations</u> in Greenlee County as of January 2020 employed approximately 3,800, with a daily average of 1,100 contractors supporting ongoing operations and several sustaining capital projects at the site.
