[Safford operations](#) currently employs 1,200 with approximately 40 contractors working on site. Lone Star, a new cornerstone asset for Freeport-McMoRan, is complete and contractor levels associated with the expansion have decreased significantly over the course of the year as project activities were completed. Contractors remaining on-site support day-to-day operations. Safford recently celebrated a production milestone with its 2 billionth pound of copper made.

[Morenci operations](#) in Greenlee County currently employs approximately 3,400. The October average number of contractors was approximately 570, supporting the site's day-to-day operations as well as planned maintenance activities.

Central Analytical Services Center (CASC) and Sanchez Technology Center (TC-S) have combined total employment of approximately 130.

FM Safford Environmental Update – 3M Program 2019 Results

Safford's 3M (Model, Monitor, Mitigate) Program stakeholder public meeting was held October 22 via webinar. Chief Environmental Scientist Mike Windsor shared the 2019 water year results from that presentation with the CPP:

- No water from the Gila River or its associated aquifer is pumped to the Safford mine

- Given the hydrologic disconnect between the Gila River’s tributaries and aquifer system, modeling and monitoring of the Safford Mine’s groundwater use from isolated aquifers show no measurable effect on the Gila River’s shallow alluvial aquifer
