## **Environmental Update**

- Reclamation work on Harrison Mountain exploration road planned for summer 2017.
- With the lower production rates, water consumption at the Mill decreased. Depending on annual precipitation and other operational factors, a positive water balance may occur. Henderson continues to assess alternatives to manage excess water, including treatment and discharge. An alternatives analysis study was completed last year, and pilot-scale tests are planned for this summer.



## **Q:** What is your global sense of the demand for molybdenum in the future?

**A:** The annual molybdenum market is approximately 500 million pounds of which Climax Molybdenum Company produces around 20%, or up to 100 million pounds.

### **Q:** What's the highest price molybdenum has ever reached in the last 15 years?

**A:** In the last 15 years, we have seen molybdenum above \$30 a pound. Today molybdenum is \$8.40 a pound. In 2015, molybdenum was above \$10 a pound, dropping to \$4 a pound in the 4<sup>th</sup> quarter of 2015/1<sup>st</sup> quarter of 2016.

### **Q:** How much molybdenum does Henderson and Climax produce as a whole for the company?

**A:** Currently, Henderson and Climax combined produce approximately 30 million pounds annually, 1/3 of the total pounds produces by all FCX mines.

# **Meeting Activity**

The Q2 meeting of the CPP was held as a joint meeting of both Clear Creek and Grand Counties. The members toured the Henderson mine underground and surface areas. The group will tour the Henderson mill at the next meeting.

# **Community Discussion Summary**

#### Leadership Initiative for Sustainable Communities

During the second quarter, the Panel welcomed the Grand County and Clear Creek County Cohorts to present an update related to their work around Increased Access to Affordable and Attainable Housing.

#### **Cohort updates:**

#### **GRAND:**

DiAnn Butler reported on Grand County. They are moving forward on a county housing assessment for 2018. Grand County will be working with DowtownCO Inc (DCI) to bring all towns/cities together for housing authority within the county. They are also working on a website that will be the platform/clearing house to show inventory of housing available. This website will allow for landlords to load their inventory of current and future availability both for sales and for rentals. The estimated cost is \$6,000. The Grand Foundation has been working on a similar website that involves volunteer opportunities within Grand County. The Grand Foundation is also developing a program to help with first, last and security deposits for residents that are unable to rent or purchase due to this hurdle.

#### **CLEAR CREEK:**

Stephan Andrade reported that Clear Creek is also working towards attainable housing outcomes. Deliverables include a decision support tool to help communities, housing developers and residents identify opportunities for the development of all forms of housing in Clear Creek. They have identified the following factors: overall demand – locations and inventory, work force housing, singly family, new houses, revitalization of mobile home parks and money and developers coming into the county to move forward. Framework development includes a funding request to the department of local affairs for \$60,000.
