The Copper Mark was awarded to Cerro Verde in Peru, El Abra in Chile, Atlantic Copper (first in their respective countries) and Miami and El Paso Refinery. Other U.S. sites are scheduled to be assessed in 2021.

Operational Work Strategy

- Pushback 62 – blasting started February 4, 2021
 - Two perimeter seismographs in addition to near, mid and far field seismographs (No event was recorded)
- Truck / shovel addition

Environmental Update

- Observing diminished flows from some older wells, causing Sierrita to narrowly miss our annual mitigation well pumping target (-2%)
- 33 total wells in the system (14 IW, 19 MW)
- 7 wells currently in some stage of rehab or pump rebuild
- 4 wells have been rehabbed in the past six months and 3 wells upcoming



- Currently conducting well optimization study to determine new well sites for aging well infrastructure, and some wells in the interceptor well field were installed more than 30 years ago

Tailings Management

Continue to evaluate / test new technology to manage tailings:

- Wind forecasting app success – supports getting the necessary personnel to run dust control equipment
- Polymer-based dust suppressant testing results – holding up better after rain
 - Currently doing infiltration testing
- Water Monitor Cannon Update – tests were effective in applying dust suppressant on hard-to-reach areas
 - Moving forward with installation on all equipment

Activities / ongoing work include tailings raise berm push work. Expected to be completed in April.
