Operations Update

Smelter Turnaround Project

- The 25-day plant shutdown in March 2025 was completed safely, under budget and on schedule.
- The project included maintenance and rebuild activities, with early work completed for projects scheduled for 2026.

Employee Experience

- Includes a mentoring program and facility improvements.
- Facility improvements include restroom renovations, new change houses, lactation pods, lunchroom upgrades and a new elevator to improve accessibility.
- The program has shown improvement in safety performance, employee retention and the overall site culture.

Sustainability Project

- Preparatory activities have begun for the Miami Smelter Sustainability Project.
- The project will replace the electric furnace and anode casting system and will provide critical upgrades to allow Miami to continue to operate.
- An 81-day shutdown is planned for May 2026 to complete these upgrades.

Environmental Update

EPA Rule Reconsideration

- The EPA is reconsidering elements of the primary copper National Emissions Standards for Hazardous Air (NESHAP) rule, particularly regarding filterable particulate matter from smelters
- The review addresses the feasibility of established limits related to available technology to meet those limits.
- Panel Question: How are air quality impacts from the smelter differentiated from other impacts? Answer: Arizona Department of Environmental Quality (ADEQ) monitors particulate samples in cumulative and Miami monitors outputs from the smelter.

Pinal Valley Soil Program

- Open house on May 14, 2025, drew approximately 50 attendees.
- Program aims to sample and characterize properties for historic mining or smelting impacts.
- Claypool outreach office will open in August to provide a physical location for individuals to visit if they have questions or want to enroll for the program in person.

Grievance Management

Grievance Report

Freeport maintains a formal Grievance Management System allowing community stakeholders to share concerns directly with company officials, which we reviewed in detail at the Q2 CPP. Learn more about this process below:



Receipt: Freeport receives concerns (grievances) from the community in person, via phone, email, website and/or mail. *The more details shared, the better, so we can properly investigate and remedy the situation.* Concerns can be submitted anonymously.

Confirmation: Freeport confirms receipt of inquiries within 48 hours of receipt.

Review: Freeport coordinates with the appropriate internal experts to review.

Response: Freeport provides a formal response to the individual or group by phone, email or mail. No formal response can be shared for those received anonymously.
