Miami Operations September 3, 2020

The <u>Community Partnership Panel</u> is hosted by Freeport-McMoRan to keep the community informed about operational activities and to foster open and ongoing dialogue to develop thoughtful solutions to address community issues.

Provided a site update for Miami operations covering the following topics:

Safety and Operations Update -

- Safety: Zero reportable incidents in in second quarter Employment: approximately 800 employees; 300 contractors
- Pandemic: minimal effect on Miami operations
- Production: on track to achieve 2020 plan on concentrates, sulfuric acid, and anodes second quarter best 12-month rolling average on concentrates

Miami Third Quarter Focus -

- People over process
 - Keep focused on COVID-19 prevention at work and off the job
 - Stay focused on safety as a priority

Smelter operations

- Improve smelter reliability
 - o Focus on technical skills / training of our employees
 - o Implement new methods / tools that help improve operating procedures
 - Complete commissioning of new blending facility
- Critical equipment care and maintenance September 2020 planned outage
 - o Replace acid plant preheater
 - Add cooling elements in Isa vessel

- Install larger feed port and roof block
- Radial flow scrubber
- Preparing for major shutdown in April 2021 (29 days)

Hydromet operations

- Implemented a water management plan for monsoon response
- Conducting resistivity study to determine potential production increases

Environmental Update -

In 2014, Miami operations was granted a significant permit revision (SPR), authorizing the installation of new emissions capture and control equipment and throughput increase to 1 million tons per year (TPY), up from 850,000 TPY. In 2017, Miami completed an upgrade to the smelter with the installation of new equipment and commenced startup.

Upon completion of the project, Miami began monitoring for compliance with voluntary limits established for lead and particulate matter emissions. Although Miami was capturing more lead and particulate matter after the smelter upgrade, data showed Miami exceeded the new permit limits for these pollutants.

Miami entered into Consent Order with Arizona DEQ in 2018 to determine the causes of the permit exceedances and return the facility to compliance with permit. Since 2018, Miami has conducted numerous studies of smelter emissions through testing of new equipment and building roofline openings to gain an understanding of the smelter's emissions profile.

Miami and ADEQ agreed, the voluntary limits in the Significant Permit Revisions (SPR) were based on insufficient data and incorrect methods for calculating emissions. This resulted in incorrect emission limits. Miami obtained an expert third-party opinion for properly accounting for emissions and calculating appropriate limits in preparation for revising permit.

Final step in Consent Order is for Freeport-McMoRan Miami to submit a permit application to establish appropriate limits. The smelter has achieved significant decreases in SO₂, lead particulate emissions with installation of new equipment.

Establishing correct emission limits is **not** a request to increase smelter emissions, rather, to establishi limits that are representative of actual smelter emissions.

Application will be submitted to ADEQ in September, which will begin significant permit revision process. ADEQ will issue a public notice and will hold a hearing in fourth quarter 2020 or first quarter 2021.
