Operations Updates:

- **Chino:**
 - 2016 Copper Production = 307 million pounds
 - Current Mining Focus:
 - Lee Hill (north end of pit) — Two shovels
 - South pit (southside) — One shovel
 - Estrella (westside) — One shovel
 - Permits:
 - North Lampbright waste stockpile — Awaiting draft permits and New Mexico Mining and Minerals Division public hearing date
 - 3A waste stockpile — Fully permitted
 - DP-459 (Santa Rita pit and associated stockpiles) — Permit renewal in progress
- **Tyrone:**
 - 2016 Copper Production = 76 million pounds
 - Current Mining Focus:
 - Mining continues in Little Rock and Valencia pits
 - Permits:
 - Two discharge plans being renewed
 - Under New Mexico Environment Department review and renewal

- Cobre Haul Road
 - Some preliminary design work is being completed.
- Standby Status
 - Responding to MMD comments relative to Freeport-McMoRan's request to come off standby status

Q: What is the timeframe for Chino Haul Road? People living in the Mimbres who travel through that area will want to know.

A: We are actively working through it. No timeline today, but we will work to keep you informed.

Q: Is the delay in the Cobre project because you are still trying to obtain the necessary permits?

A: No, the haul road is fully permitted. Right now, it is an internal process we are working through. We are working with the state for coming off standby status. You should see public notices for that. We also need to update our Stormwater Pollution Prevention Plan (SWPPP).

Q: Is there a timeframe that work has to be done before the permit expires?

A: The permits typically need to be renewed every five years.

Q: Will you use the railroad to haul material from Cobre to Chino?

A: No, we will only use haul trucks.

New Mexico Financial Assurance Requirements

- Financial Assurance Requirement
 - Requirement under the New Mexico Mining Act of 1993
 - Company must give assurance that sufficient funds are in place to allow a third party to implement the approved reclamation plan, should the operator not be capable of doing this work
- Current financial assurance requirement for FCX New Mexico Operations totals \$373 million for Chino, Tyrone and Cobre
- Financial assurance can be provided with a variety of forms, including bank letters of credit, cash held in trust, surety bonds, pledged assets and third party guarantees
- Ability to provide third party guarantees is subject to certain financial tests
- We have been working cooperatively with the State of New Mexico agencies to maintain compliance with our financial assurance obligations
 - The agencies approved reductions to the amount covered by third party guarantees to account for higher cash balances in the trust accounts and higher real estate collateral values.
 - The state agencies approved our proposal to provide the remaining part of the third party guarantees (\$104 Million) by Freeport Minerals Corporation
 - Freeport Minerals Corporation is the former Phelps Dodge Corporation. It is a separate legal entity that owns significant mine assets
 - The audited financials of this company show that it meets the financial soundness tests required by the state.

Q: Based upon the agency approvals do you meet the financial assurance requirements?

A: Yes

Q: Do you have any predictions on the Copper Production Tax Act for 2017?

A: There haven't been any changes in the ad valorem tax or production tax. The same rules are in place and there are no changes from the state.

Q: Do your byproducts, such as molybdenum, gold and silver have an effect on your bottom line?

A: Yes.

Q: Related to finances, what is the impact on contractors?

A: There was an impact on our contractors during the 2015 downturn, as we brought work in-house. We still rely on contractors to support our operations. For example, leaching crews and security services are contracted. Keep in mind our contractors are our partners.

Leadership Sustainable Communities Initiative

During the first quarter, the Panel welcomed the Grant County Cohort to present an update related to their work around placement in local skilled jobs.

The Cohort has created a survey for Grant County, Silver City employers designed to identify employee needs. These surveys are being distributed via business sector with the goal of creating a better understanding of business sector needs. In addition to that better business needs understanding the cohort hopes to identify transferable employee skill across multiple business sectors. This resource will help frame the work at identifying a placement strategy in local skilled jobs. The Cohort has been discussing holding an Education Summit with WNMU. The intent of the summit is to start a process to develop plans looking at education needs in Grant County in the future (i.e., What will Grant County education look like in 10, 20 and 30 years?). Tentatively looking at Fall 2017 for the initial summit.
