#### Freeport's Local Influence

- In 2024, New Mexico operations employed 1,130 individuals, generating a ripple effect that supported a total of 4,230 jobs across the region.
- Freeport employs around 10% of Grant County's working-age population, with most positions offering competitive salaries and bonuses.

 Direct vendor purchases in Grant County totaled \$14.1 million, and indirect employee spending locally is \$28.9 million, significantly benefiting the community.

#### **Copper Market Dynamics**

 Global copper demand is rising, especially driven by AI infrastructure and data centers, while supply is constrained due to lengthy permitting processes for new mines (up to 30 years).

#### **U.S. Copper Consumption**

 Around 70% of copper consumed in the U.S. is produced domestically, but the U.S. still relies on imports to meet demand. Freeport is recognized for its strong reputation in the U.S. market.

Freeport-McMoRan has been named one of the 50 most community-minded companies in the United States.

Nearly 300 interns stepped into roles throughout Freeport's North America sites as part of the company's 2025 summer internship program, gaining real-world experience across a variety of roles and locations. Interns focused on everything from engineering and business administration to metallurgy and geology. The program, designed to offer students and recent graduates hands-on learning, exposed them to the minining industry and provided a chance to build skills and support long-term success.

The New Mexico summer internship program had 22 interns who
participated in a wide variety of projects, including a community cleanup
event.

#### **Leach to the Last Drop**

At the Q3 2025 CPP meetings, we shared about Leach to the Last Drop, a company-wide leaching initiative for existing stockpiles, focused on innovation and sustainability.

Mines have stockpiles that are made up of ore that was previously mined, but technology at the time did not allow for recovery of all available copper. More than **39 billion pounds of copper remain in stockpiles** that we are leaching in North and South America.

Current innovation has allowed us to extract more than 200 million pounds of copper annually that were once believed "unrecoverable."

#### **Additional Benefits**

- Lowers overall carbon footprint by repurposing already mined ore
- Less water usage due to lack of need for concentrating or milling
- Cost savings

#### **Technological Advancements**

 Additional technological advancements will further scale this effort including sensoring (temperature, oxygen, etc.) analytics (AI), chemistry optimization and solution heating systems

#### **New Mexico and Leaching**

- A new "perfect" stockpile at Chino, incorporating all new technologies, is set to come online in December/January, aiming to maximize copper recovery and operational efficiency.
- These advancements are expected to double recovery rates from 2.5 to
   5.5 pounds per 10 pounds of copper placed, significantly lowering costs

- and extending mine life.
- Tyrone has approximately 3 billion pounds of copper left in old stockpiles; Chino has approximately 5.5 billion.
- Helicopters are being used to install drip irrigation lines on stockpile.
   slopes, improving leaching efficiency and safety. This method replaces manual labor and has already shown positive results, with increased copper recovery observed within weeks.

#### **Operations Update**

#### **Chino and Tyrone Operations**

- Chino's headcount is about 890; Tyrone is at 230, with Tyrone expected to drop at the beginning of 2026 as employees transfer to Chino for payroll efficiency.
- Chino's mine life extends to 2045 and Tyrone through 2032, with potential for extension as leaching technologies improve.
- Tyrone is mining only one week every three months due to profitability constraints, but leaching continues at full capacity.
- Tyrone has been honored with the "Safe Operator of the Year" award by the New Mexico Mining Association and the New Mexico Bureau of Mine Safety in recognition of its outstanding safety performance. Tyrone has also maintained over 500 days without an injury, despite recent workforce changes and stress.

#### Mill and Hydromet Expansion

- Chino's mill rebuild is complete and running regularly after setbacks from the Trout Fire and monsoon.
- The recently completed Hydromet expansion increases flow capacity, speeding up copper recovery.

#### **Environmental Update**

#### North Lampbright and Kessel Projects

- North Lampbright stockpile construction is progressing, with liner installation complete and material placement beginning.
- The Kessel project is a new waste stockpile, with the aim of securing environmental permits by 2026.

#### Reservoir 9

 Project to address water management with efforts to move water from mining areas to Reservoir 9 to enable continued mining and support water reuse/recycling.

#### **Hanover Mountain**

 Permit was submitted in 2022 to mine the remaining material in the Hanover Pit, but only a temporary permit to mine 100 feet deeper has been granted so far. The lack of a full permit creates challenges for planning and financing.

#### **Tyrone Peak Exploration**

- Exploration drilling will begin soon at Tyrone Peak. Data from a helicopter survey indicates a magnetic anomaly in this area.
- The initial plan is to start with three drill holes, with a permit in place for up to 36 drill holes.

#### **Permitting and Agency Collaboration**

 Ongoing cooperation with regulatory agencies to resolve permitting issues and support operational requirements.

#### **Social Performance Updates**

#### **Community Engagement**

- Freeport provided critical support during the Trout Fire by constructing fire breaks, clearing access roads, and allowing aerial firefighting crews to stage on company property.
- Freeport also deployed crews twice to remove silt from Bear Canyon Dam, helping reduce flood risk and protecting the dam as a vital community asset.
- The Copper Collaborative group including Freeport, Southwest Council of Governments, and local municipalities - created a five-year strategic plan that includes beautification efforts, along with other initiatives to strengthen regional resilience.
- Engagement initiatives are resulting in tangible benefits, like successful community cleanups leading to the City of Bayard receiving an \$85,000 grant to continue beautification efforts and potentially hiring a coordinator for future projects.

#### Strategic Planning

 The team solicited ideas for long-term community resilience projects, encouraging input on potential partnerships and funding opportunities. Responses highlighted priorities such as workforce housing and regional agricultural initiatives, including a dedicated agricultural trade facility.
