### **Purpose**

The <u>Community Partnership Panel</u> is hosted by Freeport-McMoRan to keep the community informed about operational activities and to foster open and ongoing dialogue to develop thoughtful solutions to address community issues.

## Copper Queen Branch Update:

- The first phase of the project to remove inactive power lines and steel towers was safely completed. We removed and recycled three steel structures (60 feet tall), fifteen poles (30 feet tall), and 3,500 feet of transmission line.
- The second phase is scheduled for completion in second quarter 2019 and will involve the removal of eleven towers (60 feet tall), and 8,500 feet of transmission line.
- Demolition of the Lavender Mill Concentrate Thickeners has been delayed. Additional opportunities to photograph and paint images of the thickeners are available.
  - As a result of a community discussion around the thickeners demolition, Copper Queen Branch collaborated with Laurie McKenna, Executive Director of Central School Project, for an artist's rendition of the Lavender Mill Concentrate Thickeners. Laurie invited artists who attended the <u>Bisbee Plein Air Festival</u> to set up onsite and capture images of the thickeners through their unique artistic perspectives. Of the 50 artists that attended the festival, seven took the opportunity to document these historical structures before they are removed. Much of the artwork is displayed at Central School.

- Reclamation crew is currently repairing some erosional features on previously reclaimed stockpiles

 Gallagher & Associates has teamed with NPL Consulting to evaluate potential funding sources as they continue to work on the feasibility study for the Queen Mine Tour.
