Copper Queen Branch

- Removal of 8,500 ft. of inactive power lines and eleven, 60-foot steel towers from areas in Bisbee is scheduled for completion in fourth quarter 2019
- Aquifer Protection Permit was issued by ADEQ on October 10, 2019
- Reconstruction of the Campbell Yard Pond began in November and is scheduled for completion in February 2020
- Re-grading of the upper south bench of the #7 Stockpile is scheduled to begin in February 2020
- Three monitor wells will be drilled east of Arizona Boulevard during the first half 2020
- Bisbee Lighted Christmas Tree on Bucky O'Neill Mountain
 - The Bisbee Christmas Tree was built from metal pipe between 1903 and 1944 on the upper support for the original Copper Queen Smelter Smokestack
 - The Christmas Tree reportedly was not lit during World War II
 - Members of the community donate light bulbs for the tree annually
 - Freeport-McMoRan personnel regularly install the light bulbs
 - Corrosion has caused the tree's metal joints to fail
 - Freeport-McMoRan installed a temporary tree on the hill across the highway from the City of Bisbee Swimming Pool
 - This is an opportunity to help select a safely accessible location that can serve the community for another 50 years and beyond
