Copper Queen Branch Update:

- An upcoming project to remove inactive power lines and steel towers may cause slight traffic delays on Highway 80 near the Lavender Pit. Another phase of the project will involve the removal of lines and towers along Hillside Avenue in Galena.
- Aquifer Protection Permit – ADEQ requested additional information for the agency's evaluation of the permit application.

Reclamation Update:

- Reclamation of the South Bisbee Stockpile is scheduled to resume in the first quarter of 2019.
- The reclamation crew is currently repairing some erosional features on previously reclaimed stockpiles.

Queen Mine Experience Update:

- Gallagher & Associates and NPL Consulting are evaluating potential funding sources as they continue to work on the feasibility study for the Queen Mine Tour.

The Panel received a presentation that highlighted the work Freeport-McMoRan has done in Bisbee. These projects are designed to mitigate long-term impacts of historic mining operations and include stockpile reclamation, stormwater management, soil remediation and groundwater mitigation.

### Community Development Update

[Prazen Living Legend of Mining Award](#) – The Freeport-McMoRan Foundation was recognized by the National Mining Hall of Fame and Museum for its significant and sustained commitment to educating the public about the importance of mining to our everyday lives.

The Freeport-McMoRan Foundation recently invested **\$130,000** through its Domestic Violence Shelter Initiative and Boy/Girl Scout grants in North America. In Bisbee, the following projects received funding:
