Drilling Program

Sierrita operations will be conducting a hydrogeological and geotechnical study of our property beginning in the first quarter of 2023

- As this occurs, drill rigs may be visible from McGee Ranch Road and the Montana Vista neighborhood in Green Valley
- We expect the drilling to be completed in the second half of 2023 and are working with our contractors to mitigate any minor impacts such as dust, noise and sound that may occur

New mitigation wells project is underway to replace an older mitigation well with a new well on company-owned property in the West Desert Trails area

- This is continuation of an effort that began in June 2006 when Sierrita signed a Mitigation Order on Consent (MOC) with the Arizona Department of Environmental Quality
- Completion of three new Point of Compliance (POC) wells along the east face of the Sierrita tailings is expected by the end of the year

Human Rights Impact Assessment

We have been conducting a rigorous risk assessment process at all of our tailings facilities and have changed some facility consequence classifications to align with the criteria of the standard. Details will be shared at the Q3 CPP meeting.

The assessment and consequence classifications will be reflected in our disclosure documents which will be updated and posted on Freeport-McMoRan | FCX in August.

Sierrita recently applied magnesium chloride to the Sierrita Tailings Storage Facility using an aerial dust suppressant application. This is not common, but an effective approach when we are having a difficult time accessing hard-to-reach areas of the facility.
