Operations Update

- Operations
 - Safety performance improvement continues
 - Attributable to personal interactions in the field and focusing on developing our new employees.
 - Thiess Mining Services integration with Climax personnel and resources – contract extension through December 2024
- Headcount
 - Current employees: Approximately 360, 70 vacancies, 155 contractors
 - Recruitment – positive engagement with Colorado Workforce, local high schools and college
 - Retention – cross-training opportunities and reduced turnover rate
 - Partnering for long-term workforce housing options in our communities
- Environmental
 - Climate Objectives
 - Climax will be testing 12, Ford F-150 Lightnings
 - We expect the trucks to arrive this summer
 - In 2022, our mine maintenance group installed block heaters on 60% of Climax's fleet to reduce heavy equipment idle time in winter months
 - Climax plans to continue outfitting the rest of the fleet in 2023
 - Use of new Liebherr haul trucks on site in 2022, Climax achieved a 4% efficiency gain (over CY2021) in tons moved per unit of fuel
 - Project Updates
 - Continuing dialogue with stakeholders to develop a science-based water standard for molybdenum
 - The standard setting hearing is now schedule for June 2024
 - McNulty overburden stockpile
 - Haul road construction to be completed this winter and more water controls and soil salvage to be completed in summer of 2023

- Tailings Storage Facilities Update
 - In 2020, the International Council on Mining and Metals, the United Nations Environment Programme and the Principles for Responsible Investment co-convened the Global Tailings Review to establish the Global Industry Standard on Tailings Management (Tailings Standard), which requires mining operators to take responsibility and prioritize the safety of TSFs through all phases of a facility's lifecycle.
 - As a member of ICMM, we participated in the development of the Standard and are fully committed to conforming to the requirements.

- We have been conducting a rigorous risk assessment process at all of our tailings facilities and have changed some facility consequence classifications to align with the criteria of the standard.
- The assessment and consequence classifications will be reflected in our disclosure documents on fcx.com that will be updated in August from the disclosures that originally were posted in 2019.
 - We will provide a presentation on the details of the assessment and classifications in the third-quarter CPP meeting.

Community Engagement / Development Update

- Community Investment Fund
 - Timeline
 - Application only, no letter of intent
 - True Impact forecast completed only by those awarded funds
 - Application open May 15 – July 14
 - Community Investment Committee
 - The Fund is governed by a Committee made up of 8 representatives from the community and 2 representatives from Climax Mine operations.
 - Community Investment Committee members will serve a term of 3 years. At the end of each term, the full Community Partnership Panel then nominates and elects a new slate of members.
 - Investment Committee members will review, evaluate and determine community programs and projects to receive charitable financial support from the Freeport-McMoRan Foundation. This will be done once a year, during one grant cycle.

Despite the closure timeline at Climax being many years in the future, closure planning and reclamation work are an ongoing process.

- Climax has developed robust reclamation and closure plans that meet and/or exceed applicable State of Colorado mining regulation requirements.
- Climax's post-mine land uses include rangeland, industrial/commercial development, and recreation; these uses are consistent with surrounding lands managed by the US Forest Service and their multiple use mandates.
- Climax endeavors to restore mine-affected lands to a sustainable state (e.g., by using native species appropriate for the altitude and climate) and has proven capable of meeting these goals through successful, award-winning reclamation practices over the past 30 years.



Economic Impact

Freeport-McMoRan's Colorado operations generated almost \$447 million in economic benefits for Colorado in 2022.
